#### **Foreword**

Each quarter the Greyhound Welfare & Integrity Commission (the Commission) publishes a report providing data in relation to retirements, euthanasia and deaths of greyhounds registered with the Commission in NSW. The publication of such data is designed to provide transparent, accurate and timely reporting of these events.

This report contains data relating to the third quarter of 2019/20, being the period 1 January to 31 March 2020. As this is the third edition of this report trend line analysis is limited.

The Commission will continue to evolve the structure and content of the report to enhance its utility.

#### **Data Sources**

The statistics contained in this report for greyhound retirements and deaths relate to notifications received by the Commission from registered participants in the relevant reporting period, in accordance with relevant Commission policies, including the Commission's Rehoming Policy.

Statistics relating to euthanasia that occurs at racetracks are based on data recorded by the Commission's On-Track Veterinarians. All other euthanasia statistics relate to notifications received from participants, including where applicable, certifications from the veterinarian who performed the euthanasia.



#### Retirements reported during the quarter

Retired greyhounds no longer race and usually become pets or are retained in the greyhound racing industry for breeding. The Commission was notified of 299 greyhound retirements that occurred between 1 January – 31 March 2020 (see Table 1).

Of the notifications received, 43.1% 129 of retired greyhounds were retained by their registered owner or trainer as a pet, and these dogs stay registered with the Commission. A further 14.4% (43) of retired greyhounds were notified as being rehomed privately by their owner or trainer to someone outside the greyhound racing industry.

The remaining greyhounds were rehomed to pet rescue or rehoming organisations. The largest single rehoming program is the Greyhounds As Pets (GAP) program managed by GRNSW, and the Commission was notified of 51 (17.1%) retirements to GAP. Notifications showed that other animal rescue and adoption agencies accepted 76 (25.4%) greyhounds into their facilities.

There were no greyhounds retired for export during this quarter.

#### Euthanasia reported during the quarter

On 1 December 2019 the Commission updated its Rehoming Policy<sup>3</sup> to require greyhounds, that could previously be euthanased following certification by a veterinarian as being unsuitable for rehoming, to be subject to rehoming requirements. This quarter two greyhounds were reported as having been euthanased due to the veterinarian certifying that the greyhound was behaviourally unsuitable for re-homing. These matters are currently under investigation.

The Commission expects that greyhounds with behavioural problems undergo a behavioural assessment via GAP or other suitable canine behavioural expert and attempts are made to rehabilitate and re-home these greyhounds. Where a greyhound is to be considered for euthanasia, other than for medical reasons, a Notice of Intent to Euthanase form must be submitted to the Commission at least 14 days prior to the date of euthanasia.

A total of 96 greyhounds were reported as euthanased 1 January – 31 March 2020. Seventy-two (75%) of these were performed by private veterinarians for medical reasons such as injury or illness. There were no reported cases of emergency euthanasia by a person other than a veterinarian. The injuries most commonly reported by veterinarians were severe bone fractures.

A wide variety of illnesses precipitated euthanasia of greyhounds, including cancers, gastric dilation and volvulus (GDV), arthritis and various co-morbidities associated with age.

Fifteen greyhounds (15.6%) were euthanased by Commission veterinarians due to a catastrophic injury that occurred as a result of racing.

#### Deaths reported during the quarter<sup>6</sup>

A total of 65 greyhound deaths were reported between 1 January - 31 March 2020 of which 32 (49.2%) were reported as being due to accidental causes. Of the remaining greyhound deaths, 19 (29.2%) were from natural or unknown causes, 14 (21.5%) were reported as being due to illness and old age, with no deaths reported due to sudden death at the track.


#### **Trend line analysis**

**Graph 1. Greyhound Retirement Trends** 



**Graph 2. Greyhound Euthanasia Trends** 


