

## GREYHOUND WELFARE & INTEGRITY COMMISSION DISCIPLINARY ACTION DECISION

Charge(s):	(1) Miss Drynan presented the greyhound 'Kurios Motion' (" <b>Greyhound</b> ") for the purposes of competing in race 4 at the Wentworth Park meeting on 13 February 2021 in circumstances where the Greyhound was not free of any prohibited substance.
Prohibited Substance(s):	4-hydroxy xylazine
Disciplinary action taken:	To suspend Miss Drynan's registrations for a period of 28 weeks, wholly suspended for a period of 12 months on the condition that Miss Drynan does not breach Rule 83(2)(a) or similar rules during that 12-month period.

## **REPORT:**

Following receipt of a certificate of analysis from Racing Analytical Services Limited, the Commission conducted an investigation into the results of a post-race urine sample taken from the greyhound, 'Kurios Motion' ("**Greyhound**") at the Wentworth Park meeting on 13 February 2021.

Further analysis of the sample was conducted by the Australian Racing Forensic Laboratory, confirming the presence of 4-hydroxy xylazine.

Miss Drynan was legally represented and did not enter a plea in relation to this charge.

The disciplinary action was conducted in writing in accordance with the participant's election.

## **DECISION:**

- 1. Miss Drynan is a registered greyhound trainer and the trainer of the Greyhound. The Greyhound competed in race 4 of the Wentworth Park meeting on 13 February 2021 ("**Event**"). After the Event, a urine sample was taken from the Greyhound.
- 2. The post-Event swab revealed the presence of 4-hydroxy xylazine. 4-hydroxy xylazine is a prohibited substance under Rule 1 of the Rules.
- 3. The Commission charged Miss Drynan with an offence under Rule 83(2)(a), which reads:
  - (2) The owner, trainer or person in charge of a greyhound-
    - (a) nominated to compete in an Event;

shall present the greyhound free of any prohibited substance.

- 4. Miss Drynan did not enter a plea in relation to the charge, had written submissions provided on her behalf and elected to have the disciplinary proceeding conducted in writing.
- 5. The Commission found the charge proven and took the following disciplinary action against Miss Drynan:

To suspend her registrations for a period of 28 weeks, wholly suspended for a period of 12-months on the condition that Miss Drynan does not breach Rule 83(2)(a) or similar rules during that 12-month period.

- 6. In taking this disciplinary action, the Commission considered all evidence, including:
  - Miss Drynan has held a trainer registration since 2012, approximately 9 years;
  - Miss Drynan did not enter a plea in relation to the charge;
  - Miss Drynan has no relevant prior matters in her disciplinary history; and
  - NSW greyhound racing precedents.
- 7. In addition, the Greyhound was disqualified from race 4 at the Wentworth Park meeting on 13 February 2021 pursuant to Rule 83(4) of the Rules.
