Decision makers determined that the penalties imposed for Charges One and Two, Charges Three and Four and Charges Five and Six were to be cumulative, totaling to a disqualification period of 15 months commencing from the date of this decision and expiring at 11:59pm on 18 August 2024, and a fine of \$400.

DECISION:

Plea:

- 1. Mr Robinson was, at all relevant times, a registered Public Trainer with the Commission.
- 2. On 6 February 2023 Mr Robinson was issued with a Notice of Charge and Proposed Disciplinary Action ("**Notice**"). The Notice issued eight charges against him for breaches of the following Greyhound Racing Rules:

Rule 21(1)(c)

(1) A person must ensure that any greyhound in the person's care or custody, is at all times provided with:



(c) kennels constructed and of a standard approved by a Controlling Body which are adequate in size and which are kept in a clean and sanitary condition;

Rule 151(2)

1) The person in charge of a greyhound must keep and retain written records detailing all vaccinations, antiparasitic and treatments administered to the greyhound:

(a) from the time the greyhound enters their care until the greyhound leaves their care; and

(b) for a minimum of two years.

2) If requested by a Controlling Body, a Steward, or an authorized person, the record/s of treatment referred to in subrule (1) of this rule must be produced for inspection.

Rule 156(f)(i), (g) and (h)

An offence is committed if a person (including an official):

...

(f) has, in relation to a greyhound or greyhound racing, done something, or omitted to do something, which, in the opinion of a Controlling Body or the Stewards:

(i) is corrupt, fraudulent, or dishonest;

(g) wilfully assaults, obstructs, impedes, abuses, interferes with, threatens or insults:

(iv) a Steward or any other official of a Controlling Body or a Club;

in or at any place, including at or in the vicinity of the place where an inquiry, other disciplinary process, hearing or appeal proceeding is to take place, is taking place or has taken place.

(h) disobeys or fails to comply with a lawful order of a Controlling Body, the Stewards, or another person authorized by a Controlling Body with official duties in relation to greyhound racing;

3. A summary of the charges issued against Mr Robinson are as follows:

<u>Charge 1 – Rule 156(f)(i)</u>

On 1 June 2022 Mr Robinson dishonestly reported to multiple GWIC staff that the greyhound 'Gagan Stacey Lee' as deceased by snake bite, when the greyhound was neither deceased and remained in his care and control.

Charge 2 – Rule 156(g)(iv)

On 1 June 2022 Mr Robinson verbally abused a GWIC Inspector in a telephone conversation.

Charge 3 – Rule 156(g)(iv)

On 2 June 2022, Mr Robinson did wilfully obstruct, impede and interfere with officials of the Controlling Body by refusing entry to, and preventing the inspection of, his registered kennels by two GWIC Inspectors.



Charge 4 – Rule 156(h)

On 2 June 2022 Mr Robinson failed to reply to a lawful order from a GWIC Inspector by refusing to answer questions regarding the alleged death of the greyhound 'Gagan Stacey Lee'.

<u>Charge 5 – Rule 156(g)(iv)</u>

On 30 June 2022 Mr Robinson did threaten and abuse a GWIC Inspector by calling him a 'grub' and a 'little fuckwit terrorist' and saying words to the effect of "you'll get turned upside down if you come in here'.

Charge 6 – Rule 156(g)(iv)

On 30 June 2022 Mr Robinson did threaten and abuse a second GWIC Inspector by calling him words to the effect of '*fucking grub*' and '*simpleton*' and by saying '*You scared...what a bunch of fuckin' poofters*".

<u>Charge 7 – Rule 21(1)(c)</u>

On 2 June 2022 Mr Robinson's kennels were not kept in a clean and sanitary condition. On 30 June 2022, Mr Robinson had failed to rectify the deficiencies identified on 2 June 2022 and his kennels were again not kept in a clean and sanitary condition.

Charge 8 – Rule 151(2)

On 30 June 2022 Mr Robinson failed to produce treatment records for the greyhounds in his care and control when requested to do so by a GWIC Inspector.

- 4. On 24 April 2022 Mr Robinson was represented at a hearing, where a plea to each Charge and verbal submissions in respect to whether the Charges should be found proven and what the appropriate penalties would be were entered on his behalf.
- 5. The Commission considered all available material and found the Charges proven. The decision makers determined to take the following disciplinary action against Mr Robinson:

Decision makers determined it appropriate that the penalties imposed for Charges One and Two, Charges Three and Four and Charges Five and Six be cumulative. Accordingly, the penalties against Mr Robinson totals a period of a 15-month disqualification commencing from the date of this decision and expiring at 11:59pm on 18 August 2024.

- 6. In taking this disciplinary action, the decision makers considered all evidence, including:
 - Greyhound racing penalty precedents in NSW and the Commission's Penalty Guidelines;
 - The length of time Mr Robinson has held a registration, being since 2021, a period of approximately 2 years:
 - Mr Robinson's pleas of not guilty to Charges 2, 3, 4, 5, 7 and 8;
 - Mr Robinson's pleas of guilty to Charges 1 and 6, which afforded him a 25% reduction that is granted in such circumstances;
 - Mr Robinson's submissions in mitigation relation to the Charges;
 - Mr Robinson's penalty history; and
 - The objective seriousness of the conduct as a greyhound industry participant.
- 7. The Commission has previously made it very clear that any abusive conduct directed at Commission staff will be treated very seriously. Commission staff perform an important role in ensuring the welfare of greyhounds and the integrity of the industry is preserved and accordingly, must be protected from conduct from participants such as in the present case. Conduct that directs abuse and threats of violence towards Commission staff will always result in significant periods of disqualification.
- 8. The Commission has provided warnings in previous disciplinary matters that such conduct against Commission employees will result in significant penalties.
